## CHAIR'S COLUMN

Dear Students,

Welcome to the 2007 – 2008 academic year. Exciting things are happening in the Department of Counselor Education. Our new MS in Mental Health Counseling program began this fall semester. We are pleased to say it is in high demand, with 20 students transferring to the program and six new students selecting that program. We have also made changes to the curriculum that impacts all students. We are now offering our own course in Research and Program. We also created two new courses: Counseling in School Settings and Counseling in Mental Health Settings. We believe that the content of these courses reflects the current state of the counseling profession and will increase your knowledge and skills.

As you already know, we have two new faculty members in our department: Dr. Bob Dobmeier and Dr. Summer Reiner. During our faculty search last year, we looked carefully for faculty who could bring needed knowledge and skills to the department. Dr. Dobmeier brings extensive experience in mental health counseling and administration and Dr. Reiner has solid experience in school counseling. They also bring much energy, enthusiasm and new ideas and innovative teaching approaches with them.

I want to inform you that the Department has been granted permission to search for another faculty line. We will be advertising for that line shortly and reviewing applicant files this fall. We plan to bring in candidates in the beginning of the spring semester. We always involve students in our interview process and look forward to their feedback.

The other important item on the Department's agenda is accreditation. Currently, we are involved in writing our CACREP self-study. The self-study will be submitted to CACREP in the spring semester and we will have a CACREP site visit sometime fall 2008. Additionally, the school counselor emphasis is accredited by NCATE. Their site visit is scheduled for April 2008. We will be talking with our school counselor students about their involvement in that visit.

Let me end this column by saying that I hope that you are having a wonderful semester. I also hope that you have time to take care of yourself and to enjoy the wonderful weather we are having.

## EDC 690: MARRIAGE AND FAMILY COUNSELING

In the spring the program will offer Marriage and Family Counseling, a survey course that will examine family systems theory and other conceptual frameworks, the predominant schools and trends in the family therapy field, and the clinical application of family therapy strategies. Students will view videotape of master family therapists demonstrating various approaches to family and marital problems. Students will also examine other relevant topics such as the family life cycle and development, cultural differences and the role of the self-of-the-therapist in clinical

practice. This course is relevant for students enrolled in college, school and mental health counseling. Whether or not you will even do marriage and family counseling, systems theory and framework will help you think contextually about your individual clients.

This course will be taught by David B. Seaburn, Ph.D., who is the Director of the Family Support Center, a free family counseling service in the Spencerport Central School District. Prior to coming to Spencerport Schools in 2005,

Dr. Seaburn was Assistant Professor of Psychiatry and Family Medicine at the University of Rochester Medical Center, where he was the Director of the Family Therapy Training Program, Director of the Psychosocial Medicine Rotation and a National Research Services Award (NRSA) Fellow. Dr. Seaburn has published extensively, including two books, and has presented nationally and internationally. Dr. Seaburn is also a graduate of this department.

## NEW CLASS OFFERED IN SUMMER, 2008

**The Use of Expressive Arts in Counseling** will be offered next summer (2008) by Mardie Howe Rossi, MA, LMHC. Expressive Arts is the use of art, music, poetry, movement, and drama to help clients/consumers identify and express thoughts and feelings, and gain new insight into existing and past issues. This process leads to healing, new creative solutions, and the development of resiliency. Expressive Arts is a research-based practice that is used in a multitude of settings such as schools, hospi-

tals, agencies, and in private counseling practices. Counselors who use the Expressive Arts do NOT have to be skilled in any of the arts. This experiential class will teach the skills of facilitating the arts in counseling with individuals and groups of all ages.

Mardie Howe Rossi has been using the Expressive Arts in a variety of treatment settings for over

15 years. She has advanced training in Expressive Arts Therapy through the European Graduate School's Expressive Arts CAGS program, and Glass Lake Studio in Albany, NY. She teaches Expressive Arts Therapy at SUNY Oswego and is currently a doctoral student in Counselor Education at the University of Rochester. Dates and times of this class are still to be determined.

## RALLY IN ROCHESTER

On October 25-27 the New York Counseling Association (NYCA) held its annual conference at the Clarion Riverside Hotel in Rochester. The theme of the conference was Counselors Uniting to Nurture the Ties that Bind Us. Counselors from across New York State gathered together to be united, to network, and to discover what is new on the horizon. NYCA is the state arm of the American Counseling Association, the national organization that advocates for coun-

selors, the counseling field, and the clients that we serve. Students from the SUNY Brockport Counselor Education Department attended. There were some excellent topics covered in the presentations and workshops including the role of high school counselors, diversity, cyber bullying, health and obesity in school aged children, job searching, school violence and peer mediation, working with autism, and mental health in the schools. Dr. Summer Reiner conducted a

best practices session on *Teacher Perceptions of the ASCA defined role of the school counselor*. Dr. Bob Dobmeier conducted a workshop on *Spirituality and mental health*. Dr. Susan Seem was a member of a panel that addressed unity in the counseling field. ## WHY IS IT IMPORTANT THAT COUNSELORS UNITE?

In June 2007 the American Counseling Association's Oversight Committee for 20/20: A Vision for the Future of Counseling reached consensus on the following items: Strengthening identity, presenting ourselves as one profession, improving public perception/recognition and advocating for professional issues, creating licensure portability, expanding and promoting the research base of professional counseling, focusing on students and prospective students, and promoting client welfare and advocacy. Each one of these items deals directly with the call for counselors to unite or requires that counselors unite to bring about its particular vision. The first two call

specifically for identity and unity in the field. The theme of the New York Counseling Association's annual conference this month is Counselors Uniting to Nurture the Ties that Bind Us. The theme of the Western New York School Counselors Consortium in January is counselors connecting with each other and with other helping professionals. This call to find our identity and then to unite around it comes from the recognition that these are times of great opportunity and of risk for the counseling field. School counselors seeking their identity, mental health licensure and insurance reimbursement, mental health services setting up on college campuses, and transition

of community counseling programs are just some of the changes with their inherent opportunities and risks that we are encountering. Now more than ever it is urgent that counselors recognize who we are as a profession. What is the one theme that unites all counselors? What do counselors bring to those in need that is unique from other professions? I suggest that while we respect and use the assessment and treatment models of our colleagues, what is unique to the assessment and intervention practices of counselors is that we look at the human being in terms of strengths and needs. We use language that empowers the client to recognize, face, and resolve

their own problems. It is necessary for the well-being of the field - counselors, counselor students, and counselor educators; for the helping professions as a whole; and, most importantly, for the clients that we serve that counselors discover and unite around their one common identity. ■

## CHILD ABUSE REPORTING AND SAVE TRAINING

The Department of Counselor Education offers a workshop once a semester on Child Abuse Reporting and SAVE Training. Students in the school counselor emphasis are required to have Child Abuse Reporting and SAVE Training. Students enrolled in the college counseling emphasis and in the mental health counseling program are required to take Child Abuse Reporting. Remember, you must complete this requirement before you enter EDC 720: Integration and Application of Counseling Concepts.

At the workshop, you will be required to sign in and out, and fill out a certificate form. The workshop instructor will forward those forms to the Certification contact person at Brockport. You will be sent a Certificate of Completion and SAVE Training and/or Child Abuse Reporting will be listed on your transcript.

If you have already taken this training and have a Certificate of Completion, you do not need to attend a workshop. You WILL, however, be

required to provide your advisor with a copy of your certificate/s. Your advisor will forward the copy to the Certification contact person at Brockport. SAVE Training and/or Child Abuse Reporting, in this instance, will not be listed on your transcript.

If you have any questions about whether or not you should attend a Department workshop, please contact your advisor.

## SUCCESS IN INDIANA

Indiana House Bill 1821 became law, effective July 1, 2007. This law reversed a 1997 decision authorizing the Indiana Psychology Board to create a Restricted Test List (RTL), a list of instruments that could only be administered by licensed psychologists or those supervised by them.

NBCC and the Fair Access Coalition on Testing (FACT) advocated strongly against all of the proposed RTLs, supporting professionals' right to administer and inter-

pret assessment instruments as long as they possess the appropriate training and experience. FACT, a multidisciplinary and nonprofit organization, is housed in NBCC headquarters. FACT organized a coalition of state and national organizations to block the formation of an RTL, and repeal the language permitting the creation of such a list. Counseling organizations involved in the coalition were the American Counseling Associa-

tion, the American Mental Health Counselors Association, the Indiana School Counselors Association, and the Indiana Mental Health Counselors Association.

The Coalition argued that state licensure boards are responsible for adjudicating complaints about professionals providing services outside their scope of training, including allegations of test misuse.

Over the past ten years, this coalition of state and national organizations has worked to educate government officials about the importance of citizens' accessibility to appropriately trained professionals. Without these collective efforts, a repeal of the RTL legislation would not have succeeded.

- Windows environment (all student computers and print jobs are authenticated access)
- 16 stations located in open areas throughout the third and fourth floors of the facility and walkup stations
- Open access for SUNY Brockport students and faculty during facility operating hours. Systems shut down 45 minutes before closing time

- Instructional labs in rooms 341 and 342 have 25 and 18 student stations and one instructor station respectively

### IRENE RIVERA DE ROYSTON SCHOLARSHIP

The Department of Counselor Education is pleased to announce the **Irene Rivera de Royston Scholarship in Counselor Education**. Irene Royston, a 1974 graduate of the Counselor Education program, currently serves as an adjunct professor at the Norfolk State University in Norfolk, Virginia. Established by Mr. and Mrs. Royston, the award was created to recognize an outstanding student in our program who has demonstrated a commitment to and a potential for excellence in the counseling field.

The award is in the form of an educational expense grant (\$500.00) annually, paid in each of the two semesters (\$250.00 per semester) following selection as a recipient. The award must be used by the recipient for educational expenses during the semesters following the receipt. The recipient must use this award for educational expenses at SUNY Brockport and may not receive the award in cash. To be eligible for this award, the student must:

- Be accepted in the Masters of Education program in Counselor Education
- Demonstrate academic excellence as judged by the department
- Have completed EDC 501 or 502 or 503 Self in Society and hold a GPA of 3.0 or higher at the time of the application
- Demonstrate a commitment to the counseling profession as judged by the department
- First preference will be given to students of Hispanic or African-American descent. Secondary preference will be given to any other student who meets the criteria in #1-4 above.

If you are interested in applying for this award you must send a one page letter to Dr. Summer Reiner

### INVITATION FOR APPLICANTS: ASGW PEG CARROLL SCHOLARSHIP

The ASGW Awards Committee invites applicants for the \$2,000 scholarship given annually to honor Marguerite "Peg" Carroll, former ASGW President and pioneer in group work. The purpose of the award is to support the study of group work and further the understanding of group dynamics. Any student interested in the field of group work is eligible for consideration by the ASGW Awards Committee. Applicants are requested to respond to the following questions:

- There are many types of group experiences such as: therapeutic and/or counseling, decision-making, task oriented, psycho-analysis, quality circles, classroom meetings, etc. What area interests you the most and why?
- Where would you obtain training in your area of interest? Be specific in respect to trainers, institutions, workshop sponsors, etc. In addition, describe your intended degree program, if it applies.
- In what setting(s) and with what population do you hope to use your expertise?
- How do you plan to assess if you and your groups are making progress? Have you had any experience with these evaluation tools? Explain fully.
- List the types of groups in which you have participated. Describe their duration and the positive and negative aspects of each experience and your role (participant, leader, intern, etc.).
- Describe your participation in professional organizations related to group work.

The application should have a cover sheet with name, address, home and work phone numbers, e-mail address, social security number, and the names and contact information of three professional references who are familiar with the applicant's work with groups. These letters should address topics such as group counseling skills, evidence of ethical behavior, and evidence of professional commitment and potential, and should be forwarded directly from the recommendation source to the address listed below and must be **received by January 31, 2008**. Electronic submissions are preferred and may be submitted via email (attachment) to: [kelly.mcdonnell@wmich.edu](mailto:kelly.mcdonnell@wmich.edu). Submissions via regular mail should include three (3) typed and double spaced copies of the application to: Kelly McDonnell, Ph.D., Western Michigan University, Department of Counselor Education and Counseling Psychology, 3102 Sangren Hall, Kalamazoo, MI 49008. Applications must be **received by January 31, 2008**. The scholarship recipient will be announced at the ASGW Luncheon at the ACA Conference in Honolulu, Hawaii. Recipients must be (or become) members of ASGW.
