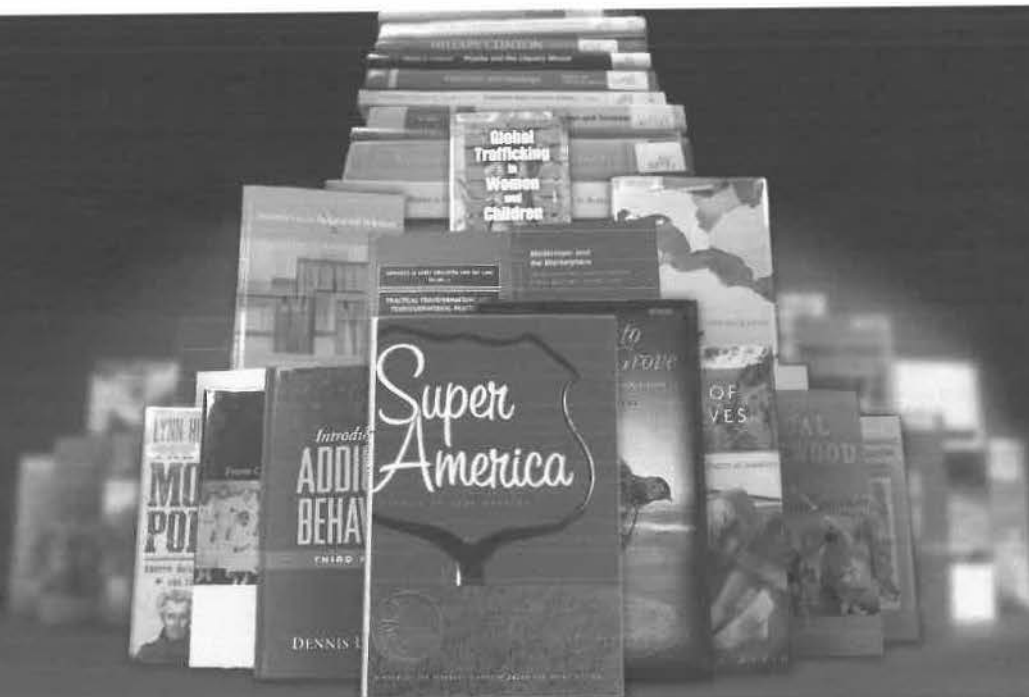

Foreward

This bibliography represents nearly 500 faculty/staff publications published at The College at Brockport during 2005-2010. It includes citations from all of the schools and many academic departments. Citations were gathered from a number of sources including a call to authors and the use of online databases. The bibliography is primarily, but not exclusively, composed of books, book chapters, DVD/films, and refereed scholarly articles.

The number of citations included since last publication of this list has increased significantly. In part, this can be attributed to Brockport's vibrant faculty with many new names and areas of scholarship represented. The bibliography also provides evidence of the many senior and emeriti faculty who continue active scholarship activities.

Bibliography Now Online

New this year is an online source for searching citations by author, department and school. The online bibliography is particularly useful in that it includes links to full text for many of the articles listed. It is our hope that future systems will allow us to keep this list updated as a living document by harvesting citations as they are published.
