Fees for the Open Recreation Program

The Faculty Senate has been asked by the Campus Recreation Activities Advisory Board and the Director of Student Activities to endorse the following recommendations for the administration of Open Recreation Program:

1. That SUC Brockport initiate a user fee policy, to become effective on January 23, 1976 for all participants in leisure activities which utilize indoor and outdoor recreational facilities owned and operated by this State University College;
2. The user fee schedule will be designed to defray the costs of programming, staffing, maintenance, and operation, as well as replace missing, stolen or damaged equipment and facilities;
3. The user fees will continue to be managed by the Campus Recreational/Leisure Activities Office on an institutional and state approved income reimbursable account;
4. The Campus Recreational/Leisure Activities Office will continue to coordinate the programming, scheduling, reserving, budgeting, staffing and overall recreational facility uses of college owned and operated facilities;
5. Guidelines will be established to assist in determining if any agencies or individuals outside the college will be allowed college facility use without being charged for maintenance and operation.

Whereas, the expenses of operating the Open Recreation Program cannot be covered through existing sources of revenue, and,

Whereas, the present funding of the program constitutes an inequity in that the students through BSG fees are required to contribute to the expenses of the Open Recreation Program, while Faculty are not required to directly contribute funds even if they make use of the program and,

Whereas, the Open Recreation Program may be forced to discontinue without additional financial support,

Therefore, be it resolved that:

The Faculty Senate endorses the five recommendations stated with the following additional provisions:

1. That the Faculty Senate, through the Faculty Environment Committee, be consulted about the exact fees to be charged Faculty for participation in the program prior to the establishment of any fee.
2. That the fee be equitable in the sense that all revenues derived from the fees be applied directly to the support of the Open Recreation Program and that the Faculty fee not exceed the Student BSG fee in any case. Faculty who have paid their BSG fees will be deemed to have paid their open recreation fees.
3. That the Faculty Senate, through the Faculty Environment Committee, have access to budget and expense records for the Open Recreation Program.
