Report of the Long Range Planning Committee presented at the Faculty Senate meeting on April 5, 1976. The Senate acted on the recommendations contained in the report ad seriatim.

- A. Moved by Senator Burelbach, seconded by Senator Cameron.

Whereas the present academic departments have not had time to evaluate the effect of the proposed (March 12, 1976) reorganization of the primary units, the Committee recommends that, following discussion of the proposed reorganization plan in the April 5, 1976, Faculty Senate meeting, Senators should meet with their departmental constituencies for discussion of the plan, and each department should develop a response in writing, to be sent by the chairperson of the department to the President of the Faculty Senate and to be used as the basis for further Long Range Planning Committee discussion. It is recommended that April 16, 1976, be the deadline for submitting departmental responses. The Committee will, on the basis of this departmental input, make further recommendations concerning reorganization at one of the May, 1976, meetings of the Faculty Senate.

Passed with 2 no votes and 4 abstentions.

- B. Moved by Senator Burelbach, seconded by Senator Cameron.

The Committee recommends that no changes be made in primary units until the Committee evaluates responses from departments concerning this aspect of the March 12 model.

Question called on motion by Senator Steinhauer, seconded by Senator Altman. Motion passed.

Vote on the main motion was unanimous.

- C. Moved by Senator Burelbach, seconded by Senator Oshier.

The Committee endorses the concept of the two Academic Vice Presidents.

Passed with 1 no vote and 1 abstention.

- D. Moved by Senator Burelbach, seconded by Senator Altman.

The Committee endorses the concept of the Office of Academic Advisement/Transcript Evaluation as shown in the March 12 model.

Adopted unanimously.

- E. Moved by Senator Burelbach, seconded by Senator Clevenger.

The Committee endorses the concept of the Operations Group as shown in the March 12 model.

Adopted unanimously.

- F. Moved by Senator Burelbach, seconded by Senator Clevenger.

The Committee tentatively endorses the concept of the four functional deans as described in the March 12 model.

Moved by Senator Schlecht, seconded by Senator Keenan, to remove the word tentatively.

Moved by Senator Mackun, seconded by Senator Gravetter, to return to committee for further study. Motion passed.

- G. Moved by Senator Burelbach, seconded by Senator Gucker.

The Committee endorses the concept of the five support offices as described in the March 12 model.

Passed with one abstention.

- H. Moved by Senator Burelbach, seconded by Senator Jenkins.

The Committee recommends the identification of an office whose function would be to supervise graduate studies.

Passed with 1 no vote and 2 abstentions.

- I. Moved by Senator Burelbach, seconded by Senator Pfeffer.

The Committee recommends deletion of the Academic and Personnel Councils as described in the March 12 model on the grounds that Faculty Senate Standing Committees already perform the functions that would be assigned to these Councils.

Senator Humm moved, seconded by Senator Gucker, to divide motion. Passed with 3 no votes.

Motion to delete Academic Council passed with 1 no vote and 2 abstentions.

Motion to delete Personnel Council passed with 1 no vote.

Dear Al:

At its April 5 meeting, the Senate devoted more than two hours to a discussion of reorganization and took formal action on a series of recommendations made by the Long Range Planning Committee.

In adopting Items A. and B. of the attached resolution, the Senate determined that more time was needed for the various departments to provide input on the plan. At the same time, the Senate did act on a number of portions of the plan to provide you input at the earliest possible date. These actions are contained in Items C., D., E., G., H., and I. of the attached report.

The Senate did not act on Item F. (the four functional deans) but referred this matter back to committee. The Senate needs clarification on the role of the deans plus departmental input.

We are hopeful that our early action on a major portion of the plan will be of help to you. We will provide further input on the remaining portions in May.
