FACULTY SENATE RESOLUTION ON COLLEGE ADMISSIONS

Be It Resolved:

That the following be established as the admissions policy for prospective first-year students applying for admission for the Fall, 1983 semester, and thereafter until further notice.

Preferred Admission:

Applicants who are graduates of an accredited secondary school will be admitted automatically if they possess both an average of 85 or above in their first three years of secondary school, and a combined score of at least 900 on the Scholastic Aptitude Test or at least 20 on the American College Test.

Regular Admission:

Applicants who are graduates of an accredited secondary school will be admitted, space permitting, if they possess an average of 80.0 or better in academic subjects in their first three years of secondary school, and either a combined score of at least 850 on the Scholastic Aptitude Test or a score of at least 17 on the American College Test. (Applicants possessing the appropriate high school average but without the required aptitude test scores may be admitted upon the judgment of a professional admissions officer, if sufficient supporting evidence is available.)

Discretionary Admission:

Applicants lacking either of the requirements for regular admission may be admitted if they possess sufficient evidence of academic potential or special talents, and if their secondary school average is 76 or above in academic subjects. They may be asked to submit additional credentials, such as letters of recommendation containing substantive information, or a personal essay. They may also be required to attend a summer session prior to the beginning of their freshman year. Decisions in the case of all those admitted on a discretionary basis will be by committee comprised of both admissions officers and faculty.

E.O.P.

1. Must be a resident of New York State.

2. Must have obtained a New York State high school diploma or its equivalent.
3. Must not be qualified to be admitted to the College under general admission standards, but must demonstrate a reasonable degree of academic potential for satisfactory completion of a degree or certificate program determined by the Educational Opportunity Program Admissions Committee.
4. Must be economically disadvantaged, usually as determined by the criteria established for the High Educational Opportunity Program administered by the New York State Education Department.
