Resolution Regarding Special Faculty-at-Large Meetings  
for Budgetary Considerations

Whereas the College is entering a period of limited growth and decreasing flexibility in the use of appropriated funds, requiring all faculty and staff to learn to work with less, and

Whereas these conditions require that the consumption of materials, the use of energy, and the costs of communications be drastically reduced, and

Whereas the continuing decline in enrollment affects the availability of both State-appropriated funds and non-State funding by sources such as the Brockport Student Government and Faculty Student Association, and

Whereas it is essential that the faculty and staff be kept fully informed of the implications of these budgetary considerations,

THEREFORE, BE IT RESOLVED that the President and his staff hold special meetings with the Faculty-at-Large for the purpose of discussing budget conditions.
