RE: Curriculum Changes in Public Administration

We would like to add an information management specialization to our current program. This specialization will not affect other departments and, therefore, does not create the problems associated with interdepartmental coordination.

Students in the management information specialization would be required to successfully complete our core courses (27 credits) and 12 credits of electives in information management for a total of 39 credits. The electives in information management would be drawn from the following list of Public Administration courses:

- PAD 620 Management Information Systems
- PAD 666 Computer Applications in Public Administration
- PAD 667 Statistics for Managers
- PAD 668 Computers in Financial Management
- PAD 669 Micro Computers For Managers

All but one of these courses, PAD 668 Computers in Financial Management, are currently offered by Public Administration. Therefore, the specialization is, in essence, a reformulation of existing courses.
