RESEARCH TIME AWARDS

Whereas,

Research/scholarship that is encouraged is more likely to be conducted.
Teaching and service demands may cause a faculty member to postpone research/scholarship.
Research/scholarship needs to be given greater visibility and more emphasis.

Be it resolved that

several Research Time Awards be made every semester. A campus wide competition will occur once a year (decisions announced no later than January 15th) with the Faculty Senate Committee on Research Policies and Procedures recommending to the Vice President for Academic Affairs those who deserve the award on the basis of the merits of their proposals. Forms and procedures for evaluating proposals will be developed by the Faculty Senate Committee on Research Policies and Procedures in consultation with the Vice President for Academic Affairs. The winners will receive a one course reduction or the equivalent in load for one semester while the winners' Departments will receive money to hire an adjunct to cover the course or, if the Department chooses to cover the load, money to spend at its discretion.

(It is hoped that these small incentives will encourage more scholarly work and generate more grant applications for the campus. We would like to see these awards be part of the three year academic improvement program.)
