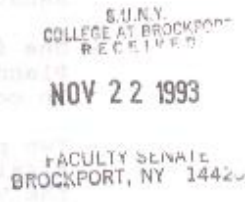

- WHEREAS: It is expedient to have one faculty body who looks across disciplines and examines the college's academic programs from a broad perspective.
- RESOLVED: The Faculty Senate appoint an Academic Program Review and Planning Committee that will serve as an advisory committee to the Executive Committee of the Faculty Senate. The committee will participate in the review process as specified in the document entitled, "Academic Program Review and Planning" and the addendum document, "Committee Charge and Function." Committee recommendations will be forwarded as described in the report.
