# Resolution Regarding Faculty Senate's Responsibilities

WHEREAS the policies of the Board of Trustees of the State University of New York empower the faculty of individual SUNY institutions with the "obligation to participate significantly in the initiation, development and implementation of the educational program" of the College, and

WHEREAS this responsibility has been faithfully discharged by this Senate and consistently acknowledged and honored by the administration of SUNY Brockport throughout the long history of this Senate, therefore

BE IT RESOLVED that the chairpersons of all academic departments, the Academic Council and the President's Staff be reminded of the Faculty Senate's responsibilities in the development and implementation of educational programs of this institution; of the consequent need to maintain close communication with the Senate concerning programs under development; and of the need to ensure that no public announcement of new or significantly altered academic programs be made until they have received the Senate's formal approval.
