I. Regular Freshmen

1. Regents diploma or minimum 16 Academic Units, including the Senior Year
 - 4 English
 - 4 Social Studies
 - 2 College Preparatory Math
 - 2 Science (one with lab)
 - 4 Additional Academic Courses, which could include foreign language, math, science, english, social studies or fine arts.
2. Minimum average of 80 or better or standing in top ½ of the graduating class.
3. Recommended SAT of 1000 (minimum 440 verbal) or ACT of 21 (minimum english 16).

II. Transition Freshmen (Summer Program)

1. Regents diploma or minimum 16 Academic Units, including the senior year
 - 4 English
 - 4 Social Studies
 - 2 College Preparatory Math
 - 2 Science (one with lab)
 - 4 Additional Academic Courses, which could include foreign language, math, science, english, social studies, or fine arts.
2. Minimum average of 77 or better or standing in top ¾ of the graduating class.
3. Recommended SAT of 950 (minimum 420 verbal) or ACT of 18 (minimum english 15).

3. Recommended SAT of 1000 (minimum 440 verbal) or ACT of 21 (minimum english 16).

II. Transition Freshmen (Summer Program)

1. Regents diploma or minimum 16 Academic Units, including the senior year
 - 4 English
 - 4 Social Studies
 - 2 College Preparatory Math
 - 2 Science (one with lab)
 - 4 Additional Academic Courses, which could include foreign language, math, science, english, social studies, or fine arts.
2. Minimum average of 77 or better or standing in top $\frac{1}{4}$ of the graduating class.
3. Recommended SAT of 950 (minimum 420 verbal) or ACT of 18 (minimum english 15).

III. Transition Freshmen (Fall Program)

1. Regents diploma or 16 Academic Units, including senior year:
 - 4 English
 - 4 Social Studies
 - 2 College Preparatory Math
 - 2 Science (one with lab)
 - 4 Additional Academic Courses, which could include foreign language, math, science, english, social studies, or fine arts.
2. Minimum average of 76 or better or standing in top ¼ of the graduating class.
3. Recommended SAT of 1100 (minimum 460 verbal of ACT of 23 (minimum english 19).

IV. Exceptional Talent Freshmen To include students that have unique or outstanding qualities such as in athletics or the fine arts.

1. Regents diploma or minimum 16 Academic Units, including senior year.
 - 4 English
 - 4 Social Studies
 - 2 College Preparatory Math
 - 2 Science (one with lab)
 - 4 Additional Academic Courses, which could include foreign language, math, science, english, social studies, or fine arts.
2. Minimum average of 76 or better or standing in top ¼ of the graduating class.
3. Recommended SAT of 900 (minimum 420 verbal) or ACT of 18 (minimum english 15).

V. EOP Freshmen For students who do not meet the regular admission criteria but who do meet income guidelines set by NYS.

1. 14 Academic units, including a minimum one year of college preparatory math-Course I.
2. Average of 74 or above.
3. SAT or ACT Scores required.
