Task Force on System Administration Consultation**

**Whereas** the Faculty of the State University of New York College at Brockport, like its sister Faculties of the SUNY Colleges and Universities, is authorized by the Policies of the Board of Trustees of the State University of New York as the official agency through which the Faculty of SUNY Brockport participate in the governance of the College and the greater University system; and

**Whereas** the SUNY Brockport Faculty Senate has long been a consultative partner with the University Faculty Senate in the development of policies and practices at System Administration; and

**Whereas** effective University governance requires regular and periodic review, reform and reaffirmation;

**Therefore, be it resolved** that the SUNY Brockport Faculty Senate unanimously supports the University Faculty Senate in recommending that the University Faculty Senate President meet with the Chancellor to create a Task Force on Faculty Senate/System Administration Consultation.

The Task Force should concern itself with searches and appointments of System administrators; the planning and development of new policy initiatives, and other matters of vital interest to system effectiveness.

The Task Force will be expected to explore and recommend the establishment of procedures for regular and systematic consultation between and among the University Faculty Senate, the Chancellor, and others within System Administration, the Faculty College of Community Colleges and the Board of Trustees.
