## MINIMUM GPA REQUIREMENT FOR PARTICIPATING IN UNDERGRADUATE/GRADUATE SEMESTER

The Office of the Registrar asked the Undergraduate Curriculum Committee to consider proposing a GPA requirement for students seeking to participate in the program that allows undergraduate students to take graduate courses and receive graduate credit during their final semester of undergraduate work.

We propose that the Faculty Senate add the following restriction to this policy:

**A 3.00 GPA is required to participate in this program.**

**Rationale:** this policy will require participants in this program to meet the basic GPA admissions standard for Graduate Programs.
