FACULTY SENATE COMMITTEE ON COLLEGE ADMISSIONS

Admission of Transfer Applicants

WHEREAS transfer applicants need to be informed, well in advance, of the number of credit hours, and the areas in which they will be accepted by the College, and

WHEREAS this information is useful to the students in making decisions regarding the acceptance of admission offers, and it also enables them to plan their course work, and

WHEREAS the Departments should be allowed to decide transfer of major and elective credit, so that the transcript evaluation process is shared by both departments and the Admissions Office, and

WHEREAS the efforts of the departments in curriculum articulation programs with other colleges need to be supported and coordinated for effective results,

BE IT RESOLVED that:

1. An offer of regular admission can be made only to those transfer applicants who have an earned 2.0 cumulative index from a regionally accredited College.
2. A transcript evaluation be made available to each transfer applicant before the applicant's Advance Deposit becomes non-refundable, provided that the applicant has submitted a completed application and transcript at least thirty days prior to final registration.
3. Transfer applicants who have declared a major be referred directly to the appropriate department for academic advisement and evaluation of major and elective credit. Evaluation of transfer credit in relation to general education requirement will be completed by the Office of Academic Advisement/Transfer Evaluation.
4. Institutional support be provided for Departmental level articulation efforts with other two and four year colleges, and high schools in New York State.
