**Whereas** the Charter School Committee of the SUNY Board of Trustees has adopted a set of regulations governing the certification for teachers in SUNY-authorized charter schools; and

**Whereas** those regulations lower the criteria for admission as well as the exit requirements for teachers to be certified to teach in SUNY-authorized charter schools, and

**Whereas** “public officials including the Speaker of the New York State Assembly, the Chair of the Assembly Higher Education Committee, other members of the Legislature, the Commissioner of the State Education Department, and the Chancellor of the State Regents, as well as leaders of SUNY teacher education programs and leaders of state and national teachers’ organizations, have opposed this action of the Charter Schools Committee”, and

**Whereas** the College at Brockport devotes extensive resources to ensuring effective educator preparation by expert and experienced faculty in the field of education, intentional programmatic collaboration with experts in other disciplines, as well as in-field placements with experienced educators, and

**Whereas** The College at Brockport meets or exceeds the standards demanded by the appropriate national disciplinary and regional institutional accreditation agencies,

**Be It Resolved** that the College Senate of the College at Brockport enthusiastically supports the University Faculty Senate’s “Resolution in Response to the Regulatory Action Taken by the Charter School Committee of the SUNY Board of Trustees,”

**Be It Further Resolved** that the resolution above will be broadly disseminated to publicize our deep commitment to the highest standards of education for teachers and dismay at the precipitous action by the Charter School Committee of the SUNY Board of Trustees.
